CONTRACT AND CONDITIONS:

If we have not received your signed Contracts and Terms & Conditions by August 31, 2019, we will begin contacting the names on our waiting list. I urge you to return your paperwork, along with your non-refundable \$50 deposit for Single and Single + Booths, \$100 deposit for Double Booths, and \$150 deposit for Triple and Quadruple Booths (made out to RGVQG) before that deadline. The cost of booths now includes electrical. We also do accept credit cards now.
